2Bparks general objectives are:

- **Protection planning and management**, in which the **Roadmap** will provide a user-friendly tool designed to support protected-area managers in familiarizing themselves with the existing guidelines and selecting the most appropriate ones.
- **Sustainable tourism and marketing for compatible growth**, which will result in the Notebook, a practical tool for public and private operators that agree to develop sustainable tourism in Mediterranean protected areas and to become members of the Eurocharter network.
- **Education and research for skills and awareness** with the **Sourcebook** and the linked **Education platform**, which will ensure a continuously updated knowledge system and will increase the employment potential of all people interested in protected areas.

The balance between improving lifestyles and wellbeing on the one hand and preserving natural resources and ecosystems on the other promotes sustainable development supported by the following key aspects: **environmental protection, economic development, social development, and cultural diversity.**


